Report of the Treasurer of the Congregation Randy Eide



Randy Eide

I begin this report once again thanking you, the congregation of First Lutheran Church, for again doing a tremendous job of meeting your pledges and supporting the church this past year!

• The first quarter ended with a profit of \$101,969 versus a

projected loss of \$3,000 and gave the church a strong start to the year.

- The second quarter also ended good but fairly flat with a small increase in YTD net income, following on the tails of the impressive first quarter. YTD net income was \$116,871.
- The third quarter ended with a profit YTD of \$25,326 even with revenues down \$161,955. The summer months are always a challenge. While concerning, expenses were also down substantially—\$188,280—and mostly attributed to reduced personnel expense.
- The year ended strong, especially December. The last quarter is always our strongest. Thanks to you, we ended the year within 2.1% of forecasted revenues, \$2,145,982, and total expenses were \$156,249 (7.1%) less than projected, totaling \$2,035,133. That left us with a nice Net Profit of \$110,848 for the year.

We will use that net profit as follows:

- \$40,000 will be carried over and used in the 2022 budget, and
- \$70,840 will go into our operating reserve account, which was set up to hold about 10% of our annual budget to be used for "a rainy day." I read somewhere that we need to "Plan ahead—It wasn't raining when Noah built the Ark." There are always difficult budgeting decisions to be made, and this year is no different.

We are now moving to 2022. I believe we have planned well and look forward to another fruitful year! I give many thanks to Pastors Dave and Lars for much help and insight provided in formulating the new budget. Pastor Lars is quite talented with a spreadsheet! Finance Director, Jody Bymers, of course is always instrumental providing us with historical numbers and muchappreciated information. Our finances are complex, but she understands them well and is always willing to "put in the time" that it takes.

The First Lutheran Church Foundation does a tremendous job and continues to be a blessing to the Church. They have managed their resources well and are presenting a gift of support to the church in the amount of \$463,279. As I have said in the past, we are blessed with a strong Foundation Board that allows us this support and also supports various other activities of the Church.

Finally, thanks to a very capable Finance Advisory Team of Pat Kyte and Orrin Anderson. This team serves as an advisory/oversight committee. They are both appreciated and are valuable to the Church with many years of experience, knowledge, and expertise.

I again leave you with fond appreciation for your much-needed support and generous giving to this wonderful church home we have. I referenced this verse in my last report, and I think it bears repeating when considering our support for First Lutheran: "Each one must give as he has decided in his heart, not reluctantly or under compulsion, for God loves a cheerful giver." 2 Corinthians 9:7

God's Grace: Our Heritage and Future Capital Campaign Jean Hoff, Capital Campaign Coordinator

COVID-19 continued to impact the capital campaign in 2021. We did not begin making phone calls for visits until May. It took some time to find members who would again be willing to make the calls and visits. It was a very slow start and continues to be challenging. Though the members are making the phone calls, return phone

calls are slow. We held forums with our former mayor, Dave Munson, sharing his thoughts on the campaign and some historical information with the attendees. These forums did result in additional pledges received for the campaign. Through all the challenges, the AMAZING NEWS we shared with the congregation on Sunday, January 2, was that the HVAC loan had been PAID IN FULL before the end of 2021. Our first goal of the campaign has been accomplished.

Now we need to look at the projects that are next on the priority list. The first project that needs attention is the tuck pointing of the bell tower and north side of the church building. This project was approved by the Church Council, and a contract for the work has been signed. The work will begin in the spring. The cost of this project is \$121,000. These two areas are crucial to the integrity of the building. We are also concerned about the stained-glass windows cracking or breaking so we have to complete this project first. Additional tuck pointing needs to take place on the south and east sides of the church building but is not an immediate concern. The additional tuck pointing would cost \$109,000.

The Church Council has not prioritized but has noted the other projects that need to be completed:

- Sanctuary ceiling estimated at \$750,000
- Atrium remodel to have additional safety for members, staff, and guests; estimated at \$160,000 (does not include the additional cameras needed)
- Sanctuary sound system estimated at \$250,000



We accomplished much in 2021, but we still have work that needs to be done. Thank you for your prayers, pledges, and gifts. Your prayers for the campaign continue to be important.

I will be preaching and teaching and providing pastoral care while Pr. Dave Zellmer will lead with faithfulness and with calm as Interim Senior Pastor through the anxiety and ups and downs that come in these transition times.

Report of the Associate Pastor for Evangelism and Outreach Ministries Jeff Backer



God is faithful!

Twenty-twenty-one has certainly been a year of joys, challenges, and transitions. What we had anticipated as being a year eventually actualizing being free from the COVID pandemic ...well, was not. As I write this report, we are in the midst of suffering increasing infection rates from the Omicron variant, and planning for 2022 is full of anticipation.

"God is faithful!" There is no doubt. You as the congregation of First Lutheran have allowed and been part of some amazing opportunities for God to speak into the lives of people. I give thanks for the ministry that we were able to carry out this year and for the amazing new opportunities that were offered. Here are just a few highlights.

Mobile VBS Trailer

A dream came true this year, as through the generous support from individuals and families, we were able to purchase and outfit a new evangelism and outreach tool. The Children's Outreach Trailer is outfitted with all that we need to host offsite VBS or day camp opportunities. This includes tables, chairs, tents, games, signage...all that we need.

Working with Youth & Family and Education & Discipleship, we recognized a need for offering an alternative way to engage children in our neighborhood. The Youth and Family staff, along with the E&O Board and other volunteers hosted our first off-site VBS on the Lowell Elementary playground on August 16. We hosted 45 children that day, and much fun was had by all. Val Pherson, Children's Minister, developed an activity/coloring book focusing on the Old Testament Bible stories about Creation, Noah's Ark, and Abraham & Sarah. I taught lessons on each of those stories that day. Kids played games, did crafts, and got to know those of us from FLC that day. It was a great event! We have hopes for doing more events in 2022, making connections with kids and young familiessharing faith together!

Lowell Elementary

Our partnership with Lowell Elementary and the Lowell community was a little different for most of 2021. Due to COVID restrictions, we were not able to be as "hands-on" involved as we have in the past. We have an amazingly dedicated group of volunteers and classroom sponsors who still supported teachers, administration, and students in some amazing ways this past year. We have been able to host fun, family events

again this fall including a literacy night, where students and their parents engaged in a Trunk or Treat style event where stories were read and kids rotated around to the back of vehicles that had been decorated to create engagement with the particular story being offered. Teachers dressed in character costumes-really a fun event! First Lutheran sponsored the cost of the event including providing volunteers and food for those who came.

We were also able to host a Polar Express movie night that was attended by 150 people in December.

Lastly, I want to thank those in the congregation who sponsored a classroom this year. We were able to sponsor 23 classrooms, the office staff, and the art and music classes.

Lowell is a Title 1 school and does not have a PTA, so classroom sponsorships are an important way to give teachers financial resources to purchase items not provided by the school district for parties or special projects. It also helps to ensure teachers do not pay for things out of their own pocket.

Events

This year we were able to reprise some of our special worship and community events.

Over the summer, we hosted worship at McKennan Park, which is always well attended by you, the congregation, and attracts many others as well. We were able to do this three times last summer, with the final Sunday being a special event with Blessing of the Backpacks and celebrating Elias Johnson-Youngquist as he transitioned to his internship. We also hosted a free picnic lunch that was well attended.

In August, we again hosted the Block Party. More than 650 neighborhood people attended that event with food, games, and live music played by Larry Olson and the band. A highlight this year was that Police Chief Jon Thum, Lowell Elementary Principal Diane Kennedy, Pr. Lars, and I were in the dunk tank. Several people who joined FLC in October and more recent new member groups first came to the Block Party.

Future Evangelism & Outreach Thoughts

It is no secret that in-person worship attendance has not bounced back to pre-COVID numbers, which at face value is concerning. Something the E&O board has been talking about for several years is that due to our media presence, we have an amazingly strong reach beyond the walls of our church. The question is: Knowing that there is a virtual campus out there,

how do we engage those who do not sit in the pews but are a regular part of our congregation through broadcast media? Each day, some of these people call us, we are asked to visit them in the hospital, some even receive visits from our visitation pastors.

Another conversation is how to shift the culture of First Lutheran to attract younger people/families. Much of what happens here caters to those who can meet during weekdays. This does not accommodate people who have a regular 8-5 work day. Recognizing and changing this pattern is the first step in engaging a new segment of younger people. These are just a couple of the things we will focus on this year in our conversations. In this time of transition, it is important to remember that God is faithful and that God will provide. We are truly blessed as a congregation, and I am grateful for all of the ways we work to make the gospel of Jesus Christ known in the world.

Barney Brandenburg

Mission:

The Care and Health Ministries of FLC promote the health and well-being of body, mind, and spirit, as well as tend to the needs of healing and comfort in these areas. We do this work remembering that God ultimately "heals the broken-hearted and binds up their wounds." (Psalm 147:3). Our ministries exist for the members of FLC and the wider community, striving to empower

and equip all Christians to compassionately care for others, following the example of Jesus.

New programs this year:

As we began 2021, we were still challenged by the limitations placed on us all due to the pandemic. We began meeting in person in April, with our first meeting focused on development of a Dementia caregivers support group. We asked representatives from the SD Alzheimer's Association to make a presentation to help guide our process. With their advice, some additional research, and careful consideration, we developed a plan to begin a support group with emphasis on developing community, emotional support, and education regarding the disease process. It is currently meeting monthly. The Board continues to be involved in supporting, coordinating, or assisting many ongoing programs as in previous years.

Current programs which emphasize Health and Wellness activities include:

- Walking programs such as "Stepping into Health" and the "Church Walkers" program
- Pickleball

The Board of Education and Discipleship teaches the formation of Christian faith by providing programming and resources through various platforms to encourage engagement with the Gospel and its relation to issues of broad social and cultural concern. Education aims to be evangelical, relevant, accessible, and of the

The Education & Discipleship board continues to carry out ministries that teach the Christian faith. We use the best practices and resources available to provide classes, devotions, Bible studies, and small groups that encourage growing our faith with the Gospel.

Key Ministries of 2021:

• First Friday Book Club: This new book club meets on the first Friday of every month at R Wine Bar



in downtown Sioux Falls. The club that represents a diverse population of First Lutheran Church members and has built relationships around commonalities shared amongst the group. The First Friday Book Club has been a great way to create and sustain small group fellowship amongst congregational members while sharing thoughts about the book, events in our lives, and a meal together.

• Lent 2021: A Lenten devotional centered around the Apostles' Creed was developed with the help of First Lutheran Church staff and congregational members.



The devotional featured many diverse authors sharing their beliefs on the different Articles of the Creed. Each article featured a devotional from a congregational member and a corresponding sermon from Pastoral staff on featured Lenten Sundays. In addition to the Lenten Devotional, a short podcast series featured various members of the congregation as well. The podcasts followed a similar structure to the devotionals, focusing on the articles of the Apostles' Creed, and featured high school students through founding members of our congregation.

- New Worship Schedule: Many board worked in collaboration to adjust the worship schedule to ensure all members of our First Lutheran Church family are able to not only worship together but also learn together as a family on Sundays.
- Scripture First: The Welcome and Community Board, Youth and Family Board, and the Education and Discipleship Board collaborated to "restart" Scripture First practices in a "post-COVID" era. Scripture First was offered on Sunday mornings



as well as on Wednesday evenings. Both were aimed to engage families not only to participate in education together but also to give opportunities for families to worship together. Sunday morning Scripture First features a short teaching from the non-preaching pastor, a hymn sing-a-long led by Zachary Brockhoff and Matt Tylutki, as well as a time to spend in learning and fellowship with other congregational members. Scripture First is open to all members of the congregation.



Mission: The Finance, Administration, and Property Board's mission is to provide for and maintain a clean, safe, attractive, and welcoming home in which the guests, professional staff, and members of First Lutheran may work and worship.

Accomplishments in 2021:

• Annual fall cleanup—The emphasis this year was the hedge on the south border

(15th street) of campus

- Addressed water damage issues along the north exterior wall of the church
- Stopped the seeping of water into interior wall along the north and east walls; this also involved new plaster and paint for affected areas
- Removed brick in two areas of exterior that had separated from the wall; discovered the cause was moisture getting into the affected area; checked by architectural and structural engineers; found that damage was local and the building is sound; cleaned and replaced bricks

A special thank you to members of First Lutheran. Four years ago, the Church Council and Property Board came to you in a special congregational meeting and asked you to approve a \$1,400,000 project, which involved a loan of some amount to replace our entire HVAC system—a request you unanimously approved. No less than four years later, due to your faith and generosity, our new HVAC system is 100% paid for. Thank you!

Looking at 2022:

One new project will be addressed in 2022. We were told by the inspecting engineers that the brick in our bell tower and steeple must be tuck pointed as soon as possible to avoid a major problem. A contract with a local contractor is in place to complete this as weather allows in the spring. Money for this project is on hand.

Support Staff:

With the retirement of longtime First Lutheran Business Administrator Marilyn McNeill and the sudden resignation of her replacement, we had to do a quick shuffle. Our Board owes a sincere thank you to the two employees who stepped up and made sure that we continued to function and things got done. Thank you, Jody Bymers and Jean Hoff. We also lean heavily on our Facilities Manager, Kent Wilson, and his staff: Jeff Hartnett and Rick East. Thank you.

2021 Goals and Accomplishments:



Mission: The Board of Worship & Music is charged with carrying out ministries that proclaim Christ in worship; the board "cares for music, instruments, and worship instruction so that God's Word may be heard, and God's praise may be sung." The board does not micromanage worship planning, which is done by the Pastors and Director of Music. Instead, we address

strategic goals, capital needs, special projects and services, outside concerts, and the maintenance and enhancement of resources necessary for worship, including volunteers and personnel.

Capital Campaign: The Board continued to discuss capital campaign priorities that affect worship and music, in particular the proposed new sound system for the sanctuary and replacement of the aged and worn-out ceiling panels in the sanctuary. Dave Hosbach, a consultant from Milwaukee, visited FLC for a second time in July to discuss progress toward a new sound system. Hosbach will complete a final design, prepare bid documents, oversee the bidding process, and supervise installation. Determining the priority and authorizing funding for capital campaign projects belongs to the Church Council.

Paraments: The new paraments, which were paid for with dedicated gifts, were delivered in January, and the white

paraments were first used on Transfiguration Sunday in mid-February. We are awaiting delivery of two additional green wall banners to be used in ordinary time. Volunteers





have been recruited and trained in caring for, storing, and changing the paraments from season to season. Many thanks to Cami Jacobsen and the rest of the

parament committee who worked tirelessly on this project: Diane Atchison, Marilyn Vandemark, Cathy Christopherson, and Shirley Barlow. **Staffing:** Bonnie Lindgren retired as director of the Carol Choir after 47 years. Her retirement led to a search for a new full-time staff member dedicated to youth music ministry. Matt Tylutki joined the FLC staff in August and is working with a parent committee to design and implement a new



youth music curriculum. In addition, Matt, Zachary, and Larry Olson have been working with confirmation staff to include music teaching as part of the confirmation curriculum.

Return to Worship: We shed some Covid-protocols from 2020 throughout the year, returned hymnals and Bibles to the pew racks, and resumed congregational singing in March. The Board worked closely with the pastoral staff to implement a new worship schedule in the fall, with two Sunday morning services and a dedicated time between services for education and fellowship. The fall schedule also marked the beginning of weekly communion at all services, which required much planning to address time constraints and to ensure adequate staffing. We are grateful to the many new communion servers, the members of the Altar Guild, the ushers, and the lectors. The Board continues its oversight efforts with these volunteers to help with recruiting, training, teaching, and scheduling.

Fall Choir: After almost two years of not singing, adult choir members returned in the fall to a single choir that rehearses weekly for one hour and sings approximately every other week. That schedule will continue until summer.

Harpsichord Gift: A generous donor provided funds to be used for the purchase of a new harpsichord to be used in worship. The process of finding an appropriate instrument is ongoing.

September 2022 Concert: The 100th Anniversary concert originally scheduled for September 2020 with Paul Jacobs, the South Dakota Symphony Orchestra, and Transept, at which a newly commissioned piece composed for choir, orchestra, and organ by Wayne Oquin of the Julliard School will be performed, has been rescheduled for September 2022.



women of the congregation, and especially celebrated members of the congregation 90+ years young. Jane King and Arlene Bich did a great job creating and presenting a








Charis Ministry Partners 2021 Report to Congregations



Dear Brothers & Sisters in Christ,

On behalf of Charis Ministry Partners, I would like to thank you for all the ways you have supported our ministry in 2021. Our partner congregations are the backbone of our organization; and without you we could not do what we do. You are the ones that support us financially, the ones that serve on our board, the ones that help with distributions, and you are our prayer partners.

My name is Cindy Haiar, and I started October 1, 2021 as the Director for Charis Ministry Partners. While I am new to this position, I am not new to Charis. I am a member of Holy Cross Lutheran Church and have served on the Charis board as their representative for over six years. I've also been a weekly volunteer at Food to You since the beginning of 2019 and have helped at the Necessities for Neighbors distribution every month at First Lutheran Church since that distribution started in September of 2018. I love the ministry that Charis is able to provide to our neighbors in the Sioux Falls area, it's far more than just handing out food and necessities. Our last distribution of the year was a dual distribution of both Food to You and Necessities for Neighbors together at First Lutheran Church. It was a busy night and we had record numbers for both programs, but the one moment that sticks out in my mind the most was when I received a gift. One of our regular guests, one that I visit with every month, because you truly do build friendships with them, stopped at my station even though they already had their food and necessities. They wanted to wish me a Merry Christmas and give me a gift, a tin of popcorn. There are no words to express what that gift meant, for someone who doesn't have much, to have thought of me and spent what was probably a lot to them on a gift for me. This is ministry, this is Charis, and this is why I love being a part of what we are doing.

With the help of one of our partner churches, WestSide Lutheran Church, we're in the process of building a new website. The new website (charissf.org) will be much more user friendly and easier to find. With their help, we have also updated our logos so they look more uniform and up to date. Next on my list is to start working on updating the brochures for both Food to You and Necessities for Neighbors, then I can start spreading the word in our community who Charis is and what we do.

2021 continued much like 2020, we stayed outside with our distributions for both Food to You and Necessities for Neighbors. We were able to bless over 3,700 families through Food to You and over 4,500 families through Necessities for Neighbors. We had generous people in our community step up and purchase turkeys at both Thanksgiving and Christmas; it was such a joy to be able to offer families a turkey for those holidays. Healthy Rides is our third program and it is normally pretty self-sufficient, however Covid-19 shook things up in the health industry and in other areas where rides were being given. A normal year for Healthy Rides was 1,200-1,400 rides; however in 2021 we will be well over 3,500 rides and 2022 is looking to be very similar.

Again, on behalf of Charis Ministry Partners, I would like to thank your congregation for all you do to help us help others. Because of your generosity, we don't just hand out food, necessities and give rides; we show God's love and grace to each and every guest we come in contact with.

With congregational support, we are better able to carry out our mission to care for, support and strengthen those in need-bringing clarity, stability, family and support to people of all ages, families of all kinds and communities of all sizes long into the next century of service.

Bethlehem is grateful for the partnership with LSS. LSS is able to do ministries that we ourselves are not able to do directly-from our neighbors nearby at the New Beginnings Center, to our new neighbors at the Center for New Americans, and the many other ministries across South Dakota. Together we can better fulfill our shared calling to love our neighbors as we love ourselves."

- The COVID-19 pandemic created many challenges. Thankfully, LSS was able to react guickly, safely and compassionately to continue services. In addition to serving clients on-site where possible, many of our services utilized telehealth technology. For individuals and families experiencing the overwhelming impact associated with separation and anxiety, services delivered through telehealth technology provided an alternative to continuing care.
- Students in the PATH program of LSS Behavioral Health Services exceeded expectations. 96% of participants improved or maintained their academic progress; 93% improved or maintained behavior incidents, and 92% improved or maintained school attendance.
- New refugee arrivals through the LSS Center for New Americans were successful in finding and keeping employment. 100% of new arrivals were self-sufficient within eight months with an average starting wage of \$15.87 per hour.

Well, hello! I am Pastor Chris Matson, the new pastor at Church on the Street. It is an honor and a thrill to accept this new call. At the same time, both Church on the Street and I miss Pastor Rebel Hurd! It was a beautiful day in October when she blessed us during her final worship. This past year, Pastor Rebel accepted a call to serve as Bishop Bill Tesch's Director of Evangelical Mission, to accompany other Mission Developers and new churches in the Northwestern Minnesota Synod of the ELCA. Thankfully, she is still behind the scenes mentoring me into this new call. For the past 13 years I've served as a pastor in the South Dakota Synod, most recently at Peace Lutheran Church in Sioux Falls where I oversaw Worship and Music as well as serving with many of the mission partners, such as Church on the Street.

While I'm the new pastor, much of the amazing ministry remains the same. Long time staff and volunteers are active. Harriet Munson, Laundry with Love Director, stepped up and led during the pastoral transition. Her position is possible because it is financially underwritten by Gloria Dei Lutheran Church. Thank you for this partnership! The board is a *working* board, volunteering at a moment's notice to provide the support needed.

The Lord continues to provide new opportunities for relationships to grow and flourish. New churches are entering into a covenant partner relationship. Every time we're running short on a kit someone is looking for, another shipment of donations arrives - often from places we weren't even expecting. On top of donations of needed supplies, we've been blessed to have many people use Thrivent Action Team cards to provide financial support to buy kit supplies. Thank you Thrivent members for supporting Church on the Street!

It's amazing what being Church together does for all of God's beloved children. Giving and receiving the love of God happens in so many ways. In my short tenure, I have walked with families moving from a shelter into their own home, and others who are facing eviction. Still others are reeling from the effects of addiction, trafficking, and mental illnesses.
